Public Comment

Mr. Diccio asked about the trash collection problem, his trash was collected on Friday morning, Mr. Kuklinski said the Township has put Keystone Disposal on a month-to-month notice. Mr. Kuklinski stated that the Township Solicitor will be at the next Township Meeting and we will answer questions at that time, they have been put on notice and the Township has advertised for new bids for trash & recycling collection.

Old Business/New Business

Bob Dries – Public Works Building Final Update – Mr. Dries thanked the Volunteer Fire Police for changing the time of their meeting so they could help direct the parking for this evening and for

attending the open house. He also thanked Mr. Ziegler, Mr. Kuklinski, and Mr. Stasik for seeing the need for this building three years ago. Mr. Dries also thanked Larry Stauffer of Larry's Home Designs for designing this beautiful building. This building will never be able to be built for this price again and he thanked Mike, Andy, Scott, Gary, McKenna, and Nick because they saved the Township between \$70,000-\$90,000 by tearing down the old building, prepping the site, and doing a lot of the drainage work themselves. Mr. Heydt wanted to thank Berks Products for all the block they donated for the retaining wall before they sold the plant to another company, and also thanked New Enterprise for donating left over unwanted concrete for the sidewalks and pads at the new building. Mr. Dries introduced Mr. Larry Stauffer of Larry's Home Designs and joked that he attended our groundbreaking ceremony in the rain & mud and now he is attending our open house in the Ice Bowl. Mr. Dries presented Mr. Stauffer with an engraved ceremonial shovel with stand and a plaque for his office. Mr. Dries stated that this is a terrific building and was greatly needed, it is long overdue, please tour the building and ask questions. Mr. Kuklinski thanked Mr. Dries and Mr. Stasik for keeping the construction of the building on track by holding weekly construction meetings on site and for taking the measures to correct any building code or construction issue that came up. Mr. Frantz commented that Matthew Weller should be added to the Special Fire Police Appointments, he was appointed last year and has all his background checks on file.
