NEXT MEETING MONDAY DECEMBER 5th, 2022 @ 7PM

The meeting of the Douglass Township Board of Supervisors was called to order at 7:08P.M. Attending were Chairman Joshua Stouch, Vice-Chairman Alan Keiser, Supervisor Sara Carpenter, Solicitor Robert Brant, Manager Pete Hiryak, Khal Hassan of Pennoni & Associates, Andrew Duncan, Chief Templin, McKenna Powanda, and approximately 7 residents/developers. A reporter was present.

Mr. Stouch led in the Pledge of Allegiance and announced that there was an Executive Session held this evening from approximately 6:00pm – 6:45pm involving personnel matters, no decisions or votes were taken.

Mr. Stouch asked if there were any additions, corrections, or comments to the minutes of November 7th, 2022 Board of Supervisors Meeting, none were given.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to approve the minutes of the November 7th, 2022 Board of Supervisors Meeting. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Mr. Stouch asked if there were any questions, comments, or corrections to the November 21st, 2022 Board of Supervisors Agenda, none were given.

A motion was made by Mr. Stouch, seconded by Ms. Carpenter to approve the November 21st, 2022 Board of Supervisors Agenda as presented. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Zoning Hearing Board – 1 Hearing re-scheduled for Wednesday, December 14th, 2022 starting @ 5:30pm

Treasurer's Report (Authorization to pay the bills) - Manager Hiryak

The unpaid bills as of November 21st, 2022 is \$205,008.61, the unusual bills are for Axon Enterprise Inc (body cameras for police department) for \$7,155.80 paid out of ARPA Fund, Gallagher Bassett Services Inc for \$2,500.00 (insurance deductible for age discrimination claim), PA UC Fund for \$3,813.25 (2023 Unemployment Solvency Fee). Copies are available in the lobby. No questions were asked on the bills.

A motion was made by Mr. Stouch, seconded by Mr. Keiser for authorization to pay the unpaid bills as of November 21st, 2022 in the amount of \$205,008.61. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Tax Collection Resolution – Act 57 (Waiver of late fee penalties to first year of occupancy taxes who failed to receive a bill) – Resolution #11212022-01.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to adopt Resolution #11212022-01 Tax Collection Resolution – Act 57 (Waiver of late fee penalties to first year of occupancy taxes who failed to receive a bill). Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to accept the Treasurer's Report as presented. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Police Department Report - Chief Barry Templin

October 2022 Police Statistics: 331 calls for service, 5 reportable accidents, 19 non-reportable accidents, 15 criminal investigations, 6 criminal arrests, 7 paper citations, 72 e-citations, 6 non-traffic citations, and 1 parking ticket. Chief Templin stated that the police department participated in this year's Truck or Treat Event at Trinity Church on October 29th, 2022. The Drug Take Back Program was held on October 29th, 2022 at our police department. Ninety-nine pounds of unwanted, unused, and expired medications were collected for proper disposal. There is a collection bin in the Township Administration Building open during normal business hours, no sharps or liquids. On October 27th, 2022 the Gilbertsville Area Community Ambulance Service re-certified all

of our officers in CPR/AED/First Aid. Other officer re-certifications were also completed that evening including Taser, OC Spray, and Expandable Baton. The Montgomery County Department of Public Safety has come out with the Montgomery County Active Shooter Response Plan. This plan is intended to provide a universal outline of how Montgomery County first responders will respond to an active shooter incident anywhere in Montgomery County. All of our officers have completed the education piece. All officers are scheduled to attend a hands-on training session with Montgomery County Western Region SWAT in January 2023. The Municipal Officers Education and Training Commission will mandate yearly training in Control Tactics starting in 2023 and beyond. We will have to look for a certified instructor or have one of our officers become a certified instructor in the near future. Ms. Carpenter asked if the funds are in the budget, Chief Templin replied that he has some remaining in his education budget line that he can use. Mr. Brant stated that it is possible to make a budget amendment if additional funding is needed. Mr. Kolb asked if the fire police are included in this training, Chief Templin replied that the training is geared more toward Police, SWAT, and EMS. General Order 111.1 Body Worn Camera (BWC) is currently being reviewed by the officers as per their bargaining agreement. After this is completed, I will send it to legal to be put on an agenda for approval in the near future. The BSWC's are in and we will be undergoing training in mid-January 2023 before there implementation.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to approve the Police Department Report as presented. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Police Bargaining Unit (4 Year Contract Proposed) – Mr. Stouch stated that there were minor changes to the contract. There is a 4% wage increase for each year of the 4-year contract, officers contribute additional fees for health coverage and retirement, and they have agreed to remove post-retirement medical benefits for all new hired police officers. Mr. Brant stated that arbitration was avoided as well as the cost and expense of unfavorable arbitration. Mr. Brant stated that the contract was resolved in good faith and commended Mr. Stouch for his hard work negotiating the contract and everyone involved with resolving the contract.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to approve the Police Bargaining Unit 4-year contract effective January 1st, 2023 until December 31st, 2025. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Police Chief Contract (4 Year Contract Proposed) – Mr. Stouch stated that Chief Templin's contract basically mirrors the police contract. Mr. Stouch stated that Chief Templin has waived his Festive Holiday Pay.

A motion was made by Mr. Stouch, seconded by Ms. Carpenter to approve a 4-Year contract for Chief Templin effective January 1st, 2023 until December 31st, 2025, waiving Festive Holiday Pay. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Solicitor Report - Robert I Brant, Esq.

Knox Box Ordinance/Key Box Ordinance – combining both into a new ordinance (BOS Review Only) Mr. Brant stated that we are waiting for any additional comments from the Emergency Services Board and Township Staff.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to accept the Solicitor Report as presented. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

GF&R and GACAS Reports

Written reports are available in lobby. The ESB Meeting Minutes for Monday November 14th, 2022 are available in the lobby, approval by the Board is requested. Mr. Duncan stated that ambulance services, funding, and staffing issues were discussed, this is a statewide problem that many municipalities are facing because the state has placed the responsibility on municipalities. There are also issues with the insurance companies reimbursing the individual for ambulance services and that reimbursement is not forwarded from each individual to the responding ambulance service. In a proactive approach, Mr. Stouch and Mr. Duncan have brought these issues to the attention of Pottstown Metro Regional Planning Commission to no avail. This will be an issue that every

municipality will face, Mr. Duncan that Montgomery County has hired a consultant to look at these issues and Chester County is also looking into these issues. Three out of the eight municipalities that participate in PMRPC are acting on these issues. Mr. Kolb said that the southwestern part of Pennsylvania already has something in place for this, Mr. Stouch commented that he actually looked into how Alleghany County handles these issues. Mr. Stouch asked if there were any additions, corrections, or comments to the minutes of the November 14th, 2022 ESB Meeting, none were given.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to approve the minutes of the November 14th, 2022 ESB Meeting. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Emergency Medical Service Appropriation Tax – ESB discussion to provide financial support for services (BOS Review Continuing) – Mr. Brant stated that discussions are ongoing with allowable tax provisions for possible adoption at the December 19th, 2022 meeting. Mr. Duncan commented that the Montgomery County Fire Chief's Association has applied for a retention and recruitment grant.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to accept the Emergency Services Reports as presented. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

Berks County Community Foundation Boyertown Area Grant - \$5,000.00 for the purchase of furniture and equipment for our training room at the new fire station.






