The meeting of the Douglass Township Board of Supervisors was called to order at 7:03P.M. Attending were Chairman Josh Stouch, Vice-Chairman Sara Carpenter, Supervisor Alan Keiser, Manager Peter Hiryak, Solicitor Wendy McKenna, Andrew Duncan, Allison Lee of Pennoni & Associates, Mike Heydt, McKenna Powanda, Cynthia O'Donnell, OIC Det/Sgt. Evans, and approximately 15 residents/developers. A reporter was present.

Mr. Stouch led in the Pledge of Allegiance and announced there was an Executive Session this evening from approximately 6pm to 6:30pm involving litigation and personnel issues, no decisions or votes were taken.

Mr. Stouch asked if there were any additions, corrections, or comments to the minutes of November 20<sup>th</sup>, 2023 Board of Supervisors Meeting. No changes were given.

Ordinance 2023-06 – An Ordinance Enacting an Earned Income and Property Tax Credit for qualified Volunteer Firefighters. Ms. McKenna opened the hearing at 7:18pm and recited the Board Exhibit List: B-1 Legal Notice, B-2 Email correspondence to the Montgomery County Law Library of November 10, 2023 transmitting an attested copy of the Ordinance,; B-3 Proof of Publication – Publication date: November 14, 2023; B-4 Ordinance 2023-06 An Ordinance Establishing a Volunteer Fire Fighter Earned Income Tax Credit and Real Property Tax Credit Program to Provide Incentives for Qualified Volunteers Serving the Gilbertsville Fire and Rescue Company; and Establishing Qualifications and Administrative Procedures, Appeals and Penalties in Accordance with Act 172 of 2016. No questions or comments were given. Ms. McKenna closed the hearing at 7:21pm.

And Establishing Qualifications and Administrative Procedures, Appeals and Penalties in Accordance with Act 172 of 2016. Keiser-Aye, Stouch-Abstain, Carpenter-Aye. Motion passed.

Resolution #12042023-01 Establishing the Annual Criteria for a Douglass Township Resident Volunteering for the Gilbertsville Fire and Rescue Company to be met to be certified under the Local Tax Credit Program. Approval needed by the BOS.

A motion was made by Mr. Keiser, seconded by Ms. Carpenter to adopt Resolution #12042023-01 Establishing the Annual Criteria for a Douglass Township resident volunteering for the Gilbertsville Fire and Rescue Company to be met to be certified under the Local Tax Credit Program. Keiser-Aye, Stouch-Abstain, Carpenter-Aye. Motion passed.

The GF&R Firefighters were present this evening and expressed their appreciation to the Board for all of their support. Mr. Hiryak stated that this Ordinance for the volunteer firefighters tax credit is a great thing and is well deserved, they are volunteers and respond to all emergencies in less than 5 minutes in all types of weather which is outstanding. They are collectively a great asset to their community.

# Treasurer's Report - Ms. Cynthia O'Donnell

Adoption of 2024 Budget – Ms. O'Donnell stated that the 2024 Annual Budget will be \$5,303,750.00, approval is required from the BOS.

A motion was made by Mr. Stouch, seconded by Ms. Carpenter to approve the 2024 Annual Budget for \$5,303,750.00. Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

2024 Tax Millage Resolution #12042023-02 (2.6 Real Estate, .5 EMS, .4 Fire Tax), adoption required by the BOS. Mr. Stouch asked Ms. O'Donnell to give an overview of the taxes. Ms. O'Donnell stated that the breakdown of Township Budget (tax millage) is as follows: 54% Police Department, 19% Administration, 14% Highways, 5% Planning & Zoning, 3% Insurance, 2% Fire & Ambulance, 2% Parks & Rec, and Buildings & Plant, Health & Libraries. Manager Hiryak stated there will be no increase in taxes for 2024.

A motion was made by Mr. Stouch, seconded by Mr. Keiser to adopt the 2024 Tax Millage Resolution #12042023-02 (2.6 Real Estate, .5 EMS, .4 Fire Tax). Keiser-Aye, Stouch-Aye, Carpenter-Aye. Motion passed.

# Conflict of Interest Abstention Memorandum

TO: Board Secretary, Marcy Meitzler, Douglass Township, Montgomery County

FROM: Joshua Z Stouch, Chairman, Board Member

DATE: 12/04/2023

Pursuant to Pennsylvania's "Public Official and Employee Ethics Law" I hereby declare that I am required to abstain regarding the following issue/motion:

- Volunteer tax relief matters concerning members of the Gilbertsville Fire Company

My conflict/reason for abstaining is as follows:

- As a volunteer firefighter of Gilbertsville Fire Company, I could potentially benefit financially from tax relief due to this issue/motion/vote should it pass

NOTE:

Section 3(J) requires the following procedure:

"Any public official or public employee, who in the discharge of his official duties, would be required to vote on a matter that would result in a conflict of interest shall abstain from voting and, prior to the vote being taken, publicly announce and disclose the nature of his interest as a public record in a written memorandum filed with the person responsible for recording the minutes for the meeting at which the vote is taken . . . . " (emphasis added)

This memorandum does **not** have to be utilized when a conflict is defined "by any law, rule, regulation, order or ordinance;' for example the School Code (Section 1111) prohibits voting to hire certain relatives.
